By offering creative, digital, and performance writing to students, WITS provides a variety of entry points for learning that emphasizes the importance of practice, revision, and collaboration. A majority of students live in underserved communities and attend low-income schools.

Creative Writing Camps - WITS partners with schools and academic institutions to offer renowned creative writing camps that address summer learning loss, nurture the growth of the imagination, and ignite a love of learning. Tuition-based revenue generated from camp supports school-based programs throughout the year.

Professional Development for Teachers and Writers - WITS fosters collaborative coaching and professional development for teachers aimed at transforming school ecosystems while inspiring literary cultures.
